ITINERARY: V.Sattui Winery requires an itinerary with contact cell phone numbers 48 hours before the event date. VSW also requires that we are your first or second stop if you are touring more than two wineries. This is to ensure the timely arrival of the group listed on the picnic contract. If the group runs one hour behind schedule the group is in violation of the picnic contract and forfeits tour, tasting and held picnic area with VSW attendant. No money will be refunded. The group will be given the food contracted for but will then make arrangements to picnic on their own without any guarantee of picnic table availability or tour vehicle parking. If groups arrive inebriated we will not serve you and your group will be asked to leave. In this instance there will be no refund. It is mandatory that large groups break up into groups of three or four when they go into the tasting room to use their coupon. Disruptive groups will be asked to leave.

PAYMENT OF FEE: An exact count of guests must be given 14 days prior to the event; **full payment for use of the facility must be received at this time.** After 14 days, no money will be refunded for a decrease in guest count. Up to two days prior to the event, guest count may be increased. ***Initial** _____

DAMAGES: Client agrees to pay any and all damages incurred at V. Sattui Winery as a result of this particular event, including missing or broken glassware. *****V. Sattui Winery does not assume any responsibility for any bodily injury, theft, or vandalism incurred by any persons as a result of attending an event at V. Sattui Winery. The client or clients agree to assume all liability for their guests.**

IMPOSSIBILITY: The performance of this agreement is subject to termination without liability upon the occurrence of any circumstances beyond the control of either party – such as acts of god, war, government regulations, disaster, strikes (except those involving the employees or agents of the party seeking the protection of this clause), civil disorder, or curtailment of transportation facilities – to the extent that such circumstance makes it illegal or impossible to provide or use the winery facilities. The ability to terminate this agreement without liability pursuant to this paragraph is conditioned upon delivery of written notice to the other party setting forth the basis for such termination as soon as reasonably practical – but in no event longer then (10) days – after learning as such basis. If the impossibility clause must be implemented by V. Sattui Winery, the full amount of your deposit will be forthcoming.
